

MINUTES

MEETING OF THE CLAIMS COMMITTEE
OF THE REPRESENTATIVE TOWN MEETING

October 22, 2008

A meeting of the Claims Committee of the Representative Town Meeting was held on Wednesday, October 22, 2008 at 7:30 p.m. in the Law Department, Town Hall, 101 Field Point Road, Greenwich, CT 06830.

In attendance were Chairman Thomas Byrne, Vice Chairman Lloyd N. Hull, Jane W. Arnone, Robert L. Beerman, John Blankley, Edward Dadakis, Edward Manganiello, and John Shulman of the Claims Committee; Town Attorney John Wayne Fox and Assistant Town Attorneys Abby Wadler and Fernando de Arango.

A motion was made to go into Executive Session and passed unanimously. Attorney Garie Mulcahey and Commissioner of Public Works Amy Siebert were available by telephone. After discussion in Executive Session, the Committee returned to public session and voted as follows:

Settlement of *Allstate v. Town of Greenwich* in the amount of Fourteen Thousand (\$14,000.00) Dollars was approved unanimously 7-0-0. (Jane Arnone, Robert Beerman, John Blankley, Edward Dadakis, Lloyd Hull, Edward Manganiello and John Shulman were present and voted in favor).

Settlement of *Santoro v. Town of Greenwich* in the amount of Seventy Five Thousand (\$75,000.00) Dollars was approved unanimously 7-0-0. (Jane Arnone, Robert Beerman, John Blankley, Edward Dadakis, Lloyd Hull, Edward Manganiello and John Shulman were present and voted in favor).

Chairman Byrne arrived following the discussion and voting on the *Allstate* and *Santoro* matters.

Settlement of *Pompa v. Town of Greenwich* in the amount of Seven Thousand Five Hundred (\$7,500.00) Dollars was approved 6-1-1. (Jane Arnone, Robert Beerman, John Blankley, Lloyd Hull, Edward Manganiello and John Shulman voted in favor; Tom Byrne abstained and Edward Dadakis voted against.)


Settlement of *Valentine v. Town of Greenwich* in the amount of Seventeen Thousand Five Hundred (\$17,500.00) Dollars was approved unanimously 8-0-0. (Jane Arnone, Robert

Beerman, John Blankley, Edward Dadakis, Lloyd Hull, Edward Manganiello, John Shulman and Tom Byrne were present and voted in favor.)


The Committee discussed the status of *Boucher v. Town of Greenwich* and no determination was made.

Settlement of the *Fairclough* claim against the Town of Greenwich in the amount of Seven Thousand Five Hundred (\$7,500.00) Dollars was approved unanimously 8-0-0. (Jane Arnone, Robert Beerman, John Blankley, Edward Dadakis, Lloyd Hull, Edward Manganiello, John Shulman and Tom Byrne were present and voted in favor.)
