_____ I will attend or send authorized volunteers, staff, or contractors to the GeesePeace egg oiling training sponsored by the Town of Greenwich. I understand that the names of these individuals will be sent to US Fish and Wildlife Service for inclusion in the Town wide permit for Greenwich. A record of nest location and number of eggs oiled will be sent to the Town of Greenwich after nesting season ends in mid May. I understand there is no fee for training or participation in the GeesePeace in Greenwich egg oiling program.

_____ Single Family residential and entities without available staff: I will allow GeesePeace, its employees, agents, volunteers or Town of Greenwich staff, with *GeesePeace in Greenwich* identification badges to oil eggs on my property within the described jurisdiction and provide access to this property for this purpose at reasonable times. I understand this is a no fee service subject to availability of GeesePeace or Town resources.

I understand that this activity may involve several visits to each site to identify nests, monitor egg production and to carry out egg-oiling activities. I understand that some nests may not be found and some eggs may be too developed to oil. I further understand that all personnel oiling eggs shall have in their possession a copy of the U.S. Fish and Wildlife Service permit issued to the Town of Greenwich, this signed consent form and GeesePeace in Greenwich identification.

I do hereby consent to allow, at reasonable times, including during actual operations, free and unrestricted access to this property by any Fish and Wildlife Service special agent, as required under federal regulations for depredation permits.

Hold Harmless

I agree to hold harmless the Town of Greenwich, U.S. Fish and Wildlife Service, GeesePeace and its agents or volunteers and the local coordinating body or governmental jurisdiction for any damage to person or property that results, in relation to this activity, whether through negligence, act of God or other cause.
