DESCRIPTION: MEMBERSHIP is required to play Platform Tennis. Players who purchase a seasonal rental for \$300 will be given 2 one hour time slots per week. Reservations must be made at the time of purchase for the entire season.

REGISTRATION: Starts Tuesday, October 27, 2009, BY MAIL ONLY. Should not be postmarked earlier than October 27, 2009. Registration begins Monday, November 2, 2009 in the office.

NO FEE for residents 65 and older - they may use their senior park pass, but still need to register in order to be given access to the courts.

SEASON: The courts will be open November 2, 2009 through April 2, 2010.

COURT LOCATION: Loughlin Avenue, Cos Cob

Court 1 is closest to the field/playground.

Court 2 is closest to the tennis courts.

Lights are on Tuesday – Thursday from dusk to 9:00 pm. **New this year:** Reservations will start on the hour 9am – 8pm.

COMMENTS:

- Players must wear tennis shoes while on the courts.
- During open time players are asked to limit play to one hour if others are waiting.
- During times of snow the courts are low priority and will be cleared after sidewalks and other access ways. The courts will not be cleared on weekends. Please do not attempt to clear them as the surface may become damaged or unsafe. Call 203 618-7650 for weather/playing information updates.
- Any lost court time due to snow, ice, rain, or repairs, can be made up by calling the office – 203 622-6478.
- Players are responsible for locking the courts. Please call and notify us if there is a light out or a problem at the courts.
